**ORDINANCE NO. 2012-04
AN ORDINANCE TO DESIGNATE CLASS "B" HIGHWAYS**

An Ordinance providing for the creation and adoption of "Chapter XXV – Designation of Class "B" Highways" to be added to and become part of the Code of Ordinances for the Town of Spring Prairie, Walworth County, Wisconsin.

The Town Board of the Town of Spring Prairie, Walworth County, Wisconsin, has the specific authority under Wisconsin State Statutes Section 349.15(2) to adopt this ordinance.

This ordinance, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, designates all Town highways as Class "B" Highways in the Town as follows:

SECTION 25.0: "CHAPTER XXV – Designation of Class "B" Highways" of the Town of Spring Prairie Code of Ordinances is hereby created, established and adopted in the form attached hereto.


- a. The following Town highways in the Town of Spring Prairie, Walworth County, are designated as Class "B" Highways subject to the weight limits set forth in Sec. 348.16(2), Wisconsin Statutes, unless increased by Town ordinance (See Exhibit A)
- b. The Town Chairperson, or his or her designee, shall place appropriate traffic signs on the above described highways on or before the effective date of this ordinance.
- c. No person may operate any vehicle on the above-noted highways in violation of weight limits set forth in Sec. 348.16(2), Wisconsin Statutes. Any violation shall be subject to penalties under Sec. 348.21, Wisconsin Statutes.
- d. Farm vehicles operating on Town highways in the normal course of farm business shall be exempt from the weight restrictions placed by this Ordinance.
- e. PENALTY for violation of any provision of this Ordinance shall be forfeiture as provided under Sec. 348.16, Wisconsin Statutes, together with the costs of prosecution.
- f. ENFORCEMENT. This Ordinance may be enforced by the issuance of a citation by officials or designees of officials authorized to issue overweight limit citations.


SECTION 25.1: This Ordinance and Chapter XXV created hereunder shall become effective after passage and posting as required by law.


