RESOLUTION 2015-06 TO REVISE LOCAL LEGAL POSTING LOCATIONS

WHEREAS: Wisconsin Statute 985.01(7), 985.02 (2) (a), 985.02 (2) (b), 985.02 (2) (c), 985.02 (3) and 985.08 (1) provide a method of notification of legal notices;


WHEREAS: Under previous law, a municipality must post notices in at least three (3) public places likely to give notice to persons affected, and must post a notice that would be published before the act or event requiring notice no later than the time specified for the first newspaper publication, or if the notice would be published after the act or event requiring notice, must post the notice within one week after the act or event; and

WHEREAS: Under 2015 Senate Bill 137, signed into law on November 11, 2015, a municipality that opts to post a legal notice in lieu of publication may, instead of posting the notice in three (3) public places, post the notice in one (1) public place and publish the notice on the municipality's internet website;


NOW THEREFORE BE IT RESOLVED: That the Town of Spring Prairie, Walworth County, Wisconsin does hereby consider our Town website and the posting board at our meeting location to be our legal posting locations.

This resolution repeals any previous resolutions or ordinances pertaining to posting locations.


